<b>Sl. No.</b>	<b>The school is directed to ensure that :</b>
1	The total number of section of the school shall be restricted to 15. Further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft.
2	Proper handle/ support system is not seen in Boys CWSN toilets / commode. Hence the school is directed to fix the handles in both the sides of boys CWSN toilets.
3	There is a uncovered drain is seen in the RC video. Hence the school is directed to cover the drain for the safety of students.
4	The math lab is seen without any storage area.The school install/create proper storage space, as per SoP of math lab issued by the Board.
5	The school shall conduct training of its teachers with CoE Vijayada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until

compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
